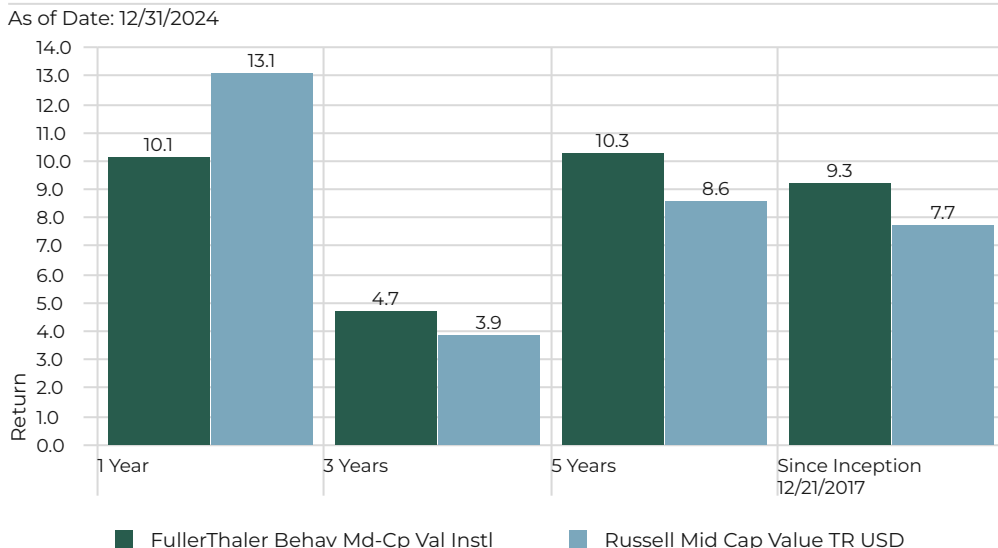

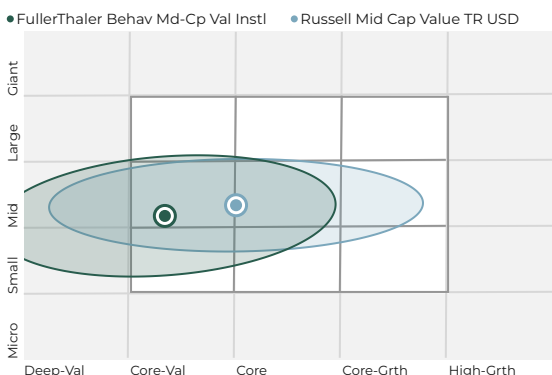
Annualized Trailing Returns⁴
